At least 2 production areas and 1 production-related area (e.g. maintenance, R&D) must be audited and achieve "Best in Class" (reach at least 95% audit result).

At least 2 indirect/ administration areas (ex. Human Resources, Purchasing) must be audited and achieve "Best in Class" (reach at least 95% audit result).

Basis for the 5S Best in Class audit are the corresponding (production/office) audit questionnaires (the latest version).
